# ORDER GRANTING APPLICATION TO INTERVENE

On March 10, 2022, Union Electric Company d/b/a Ameren Missouri filed a request asking the Commission to grant it a variance from 20 CSR 4240-22.080(1)(C). Specifically, Ameren Missouri seeks to delay its next required triennial compliance filing from April 1, 2023, until October 1, 2023. On March 15, 2022, Missouri Industrial Energy Consumers filed an application to intervene. Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission. Ten days have elapsed, and no party has objected to the application to intervene. The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

- 1. Missouri Industrial Energy Consumers' application to intervene is granted.
