**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE,
DIRECTING FILING AND SUSPENDING TARIFF**

Effective Date: December 6, 2018

On December 3, 2018, Union Electric Company d/b/a Ameren Missouri submitted to the Missouri Public Service Commission revised tariff sheets to implement a general rate increase of \$4,264,318, or 3.3%. The proposed tariff sheets have an effective date of January 2, 2019.

Section 393.150, RSMo, authorizes the Commission to suspend the effective date of the proposed tariff sheets for 120 days, plus an additional six months to allow for a hearing. Accordingly, in order to determine if Ameren Missouri's proposed tariff sheets are just, reasonable and in the public interest, the Commission will suspend the tariff sheets for 120 days beyond the effective date. Further, because a hearing cannot be concluded within 120 days, the Commission will suspend the tariff for an additional 6 months.

The Commission will schedule an evidentiary hearing in this order and will reserve dates for a true-up hearing. By establishing the hearing dates now, the Commission will ensure that this matter is heard as expeditiously as possible. Additionally, the early establishment of the hearing dates will allow ample time for notice to be sent to customers. The Commission will also set an early prehearing conference and require the parties to agree on a proposed procedural schedule. Staff will have primary responsibility for

preparing the proposed procedural schedule. The Commission will also direct the parties to file recommendations regarding local public hearings. The Office of the Public Counsel will be responsible for filing these suggestions.

The Commission will direct its Data Center to serve a copy of this order upon the county commission of the counties in Ameren Missouri's service area. Additionally, the Commission will direct the Public Policy and Outreach Department to make notice of this order available to the media serving Ameren Missouri's service area and to the members of the General Assembly representing those areas. Finally, the Commission will set a date by which applications to intervene shall be filed.

THE COMMISSION ORDERS THAT:

1. The proposed, revised tariff sheets, filed under Tariff File No. YG-2019-0113, by Union Electric Company d/b/a Ameren Missouri, are suspended for 120 days from January 2, 2019, to May 2, 2019.

3. The proposed, revised tariff sheets suspended for 120 days in ordered paragraph 1 and 2, are suspended for an additional six months beyond May 2, 2019, to November 2, 2019.

4. An early prehearing conference shall be held on January 7, 2019, at 10:00 a.m., in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.

5. An evidentiary hearing is scheduled for August 19-30, 2019, beginning each weekday at 9:00 a.m. The evidentiary hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.

6. The parties shall file a proposed procedural schedule by January 4, 2019. The Staff of the Commission shall be responsible for filing this schedule.

7. No later than January 4, 2019, the parties shall file recommendations regarding local public hearings. The Office of the Public Counsel shall be responsible for this filing.

8. Union Electric Company d/b/a Ameren Missouri shall notify affected customers of the scheduled hearings. The form and time of the notice shall be agreed upon by the parties and filed in this docket.

9. The Commission's Data Center shall mail a copy of this order to the county commission of each county within Union Electric Company d/b/a Ameren Missouri's service areas.

10. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing Union Electric Company d/b/a Ameren Missouri's service area and to the news media serving therein.

11. All hearings will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. 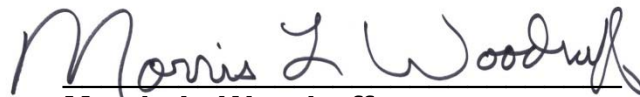
