On November 2, 2018, the Commission issued Notice of Contested Case and Orders for Small Formal Complaint. The Commission ordered the Staff of the Public Service Commission (“Staff”) to investigate the complaint and file a report detailing staff’s recommendations no later than December 17, 2018. On December 7, 2018, the Staff filed a Motion for Extension of Time. Staff’s motion states that it needs more time to fully investigate the complaint because the Complainant amended his complaint on December 3, 2018, and alleged an additional issue. The Commission will grant the motion.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time of the Staff of the Missouri Public Service Commission (“Staff”) is sustained.

2. Staff shall investigate the complaint and amended complaint and file a report detailing staff’s recommendations no later than January 15, 2019.
