On December 6, 2018, Kansas City Power & Light Company ("KCP&L"), KCP&L Greater Missouri Operations Company ("GMO"), the Commission's Staff, and the Office of the Public Counsel participated in a procedural conference. KCP&L and GMO represented that they are working toward a settlement and asked for an additional 30 days to negotiate. No party objects to the additional 30 days. The Commission will order the parties to file a settlement or status report by January 11, 2019.

1. The parties shall file a settlement or status report no later than January 11, 2019.
