ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

On September 20, 2018, the Commission issued its *Order Approving Transfer of Assets and Granting Certificates of Convenience and Necessity*. Among other things, the order directed Missouri-American Water Company (MAWC) to submit new tariff sheets in compliance with the order. On November 8, 2018, MAWC filed the new tariff sheets (Tariff File Nos. YW-2019-0087 and YS-2019-0088) with an effective date of December 8, 2018. MAWC filed a substitute tariff sheet on November 15, 2018.

On November 16, 2018, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation to approve the tariff sheets. Staff stated that it had reviewed the tariff filings and found them to be in compliance with the Commission's order. No other responses were received.

After reviewing the tariff sheet and the Staff recommendation, the Commission finds that MAWC's tariff sheets comply with the Commission's order and will approve them.

THE COMMISSION ORDERS THAT:

1. The tariff sheets filed on November 8, 2018, and substituted on November 15, 2018, in Tariff File Nos. YW-2019-0087 and YS-2019-0088, by Missouri-American Water Company are approved to become effective on December 8, 2018.
2. This order shall become effective on December 8, 2018.
3. This case shall close on December 9, 2018.
