On December 10, 2018, Kansas City Power & Light Company (“KCP&L”) and KCP&L Greater Missouri Operations Company (“GMO”) filed a status report as ordered November 13, 2018. KCP&L and GMO represent that the parties are working toward a settlement agreement and ask for an additional 30 days to file either a settlement or another status report. They also state that no party objects to the additional 30 days. The Commission will order the parties to file a settlement or status report by January 9, 2019.

THE COMMISSION ORDERS THAT:

1. The parties shall file a settlement or status report no later than January 9, 2019.

2. This order shall be effective when issued.
