On December 10, 2018, the Commission conducted an evidentiary hearing in this matter. The Commission will issue orders setting a briefing schedule and parameters on the treatment of certain issues.

The Commission will caution the parties about tendering arguments which relate to the mediation ordered and conducted in this cause, to settlement offers, or to how the parties may have treated the mediation and settlement process. The Commission will require that any party who briefs these subjects will be expected to cite the Commission to specific legal authority that supports that party's belief that the Commission may consider such evidence. The Commission cautions that an argument that the Commission may consider such evidence as relevant to credibility should be supported by specific controlling authority.
