On December 14, 2018, a Non-Unanimous Stipulation and Agreement ("Agreement") was filed by the Staff of the Missouri Public Service Commission and Union Electric Company d/b/a Ameren Missouri. Included as Attachment A to the Agreement were sample tariff sheets concerning interim rates conforming to the agreement.
