On December 14, 2018, a Non-Unanimous Stipulation and Agreement (“Agreement”) was filed by the Staff of the Missouri Public Service Commission and Union Electric Company d/b/a Ameren Missouri. Included as Attachment A to the Agreement were sample tariff sheets concerning interim rates conforming to the agreement.

The proposed tariff sheets included as Attachment A to the Agreement are not tariff sheets filed by the company with the Commission, but merely an exhibit to the Agreement. The company shall file conforming tariffs with the Commission.

THE COMMISSION ORDERS THAT:

- 1. Union Electric Company d/b/a Ameren Missouri shall file tariffs in compliance with the terms of the Agreement and the sample tariff sheets included as Attachment A to the Agreement no later than December 18, 2018.

- 2. This order is effective when issued.


