ORDER DENYING MOTION TO REVISE ORDER TO ALLOW 30 DAY PERIOD FOR INTERVENTIONS

On December 13, 2018, the Office of the Public Counsel ("OPC") filed its motion requesting that the Commission revise its prior order and allow 30 days for intervention. In support of its motion OPC states that it is the practice of the Commission to allow 30 days for intervention in cases such as the filing for a rate increase. OPC also included a statement from a newspaper editor representing that the deadlines appear to be shorter.

OPC is correct that there was no indication in the filings that the deadline needed to be shortened. Tariffs were filed in this case for an increase in revenues for natural gas service, and also for an interim rate reduction with an effective date of January 2, 2019. The shortened intervention period was designed to draw attention to the interim rate tariff and encourage potential interested parties to intervene and comment on the proposed interim rate tariff.

Parties filing an out-of-time motion to intervene will be given consideration for good cause shown. The Commission will deny the motion to revise the Commission's prior intervention order.

IT IS ORDERED THAT:

1. The Office of the Public Counsel's motion is denied.
3. This order shall be effective when issued.
