ORDER CONSOLIDATING CASES, AMENDING PROCEDURAL SCHEDULE, AND SETTING LOCAL PUBLIC HEARING

On November 18, 2018, The Empire District Electric Company (Empire) filed a motion to consolidate File Nos. EA-2019-0010 and EA-2019-0118 involving requests for certificates of convenience and necessity to establish wind generation facilities in Barton, Dade, Jasper, and Lawrence Counties in Missouri, and in the state of Kansas. Empire states that the two files are sufficiently related regarding questions of law and fact that consolidation of the cases would be administratively expedient.

The Office of the Public Counsel responded to the motion to consolidate with a proposed amended procedural schedule for the consolidated cases. Empire replied that one of its witnesses was not available on the proposed hearing dates, but otherwise did not object to the changes. No other responses to the motion to consolidate or to the proposed amended procedural schedule were filed.

These cases involve related questions of law and fact, and the Commission finds it reasonable to consolidate them. The Commission will also amend the procedural schedule as set out below.¹

Public Counsel also requested that the Commission schedule a public comment hearing prior to the filing of surrebuttal and cross-surrebuttal testimony. The Commission will schedule that comment hearing by this order.

THE COMMISSION ORDERS THAT:

- The Motion to Consolidate is granted.
- 2. File Nos. EA-2019-0010 and EA-2019-0118 are consolidated, and File No. EA-2019-0010 is designated the lead case.
- 3. All procedural requirements set out in the *Order Setting Procedural Schedule*, issued on November 15, 2018, in File No. EA-2019-0010 remain in effect with the exception of the dates set out below:

- 7. The Commission's Public Policy and Outreach Department shall make an informational presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.

The Empire District Electric Company, the Commission's Staff, and the Office of the Public Counsel shall each prepare a one-page statement outlining their current assessment of the case, and shall bring sufficient copies for distribution at the question-and-answer session that begins the local public hearing.

- 9. The Empire District Electric Company, the Commission's Staff, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer session.
- 10. Any other party, at its discretion, may prepare a statement and make a representative available to address substantive issues during the question and answer session.
