To whom this may concern with the Public Service Commission. I have been waiting for crucial information that leads back to a matter in which I believe that Ameren needs to not only be investigated, but also prosecuted for trying to attempt to illegally HiJack my email account with the email that regards the payment agreement at question.

Prior to the evidentiary hearing on the dates of on the dates of October 3, 2023 through the dates of October 5th and even on October 6th, 2023, my data mitigation provider or network security provider pinged a possible network threat and email threat to my email accounts. I take not only my business email address personal and make sure all data is secured, but also data included in my personal email accounts are secured in addition.

My data security provider did an investigation into the matter and was able to locate the IP address and trace the IP address of the party that attempted to breach my email account login and HiJack my email account.

The email account of the receipt that tried to hack is the corresponding information as below. Please make sure the data is secure from any public viewing and only available between i the party that was attempted to be hacked, along with the PSC and Ameren Missouri.

The Origin AS was [REDACTED].
Net Handle was registered at [REDACTED].

The registered owners of the IP addresses belong to Ameren Missouri and are Registered under Ameren Internet Registry.

At this point my data network provider will be reaching out to their legal counsel to proceed with filing a complaint and I would like answers from Ameren Missouri on this matter by no later than 5 pm on Monday October 23, 2023.

Due to confidential reasons of this matter I will not include other information in which my data network has in their possession and what I have been given to take to the Cyber Crimes Unit to file a complaint against Ameren Missouri.

I believe Ameren Missouri will continue to lie about this matter. All and any data breaches or distrubtions to my networks or email accounts are recorded in real time.

Due to other privacy, I will not publish or produce that in this filing to the PSC or Ameren. If Ameren wishes to correspond with me on this and my data network company they can reach out to me via email and or phone.

At this point, there is no more reasoning with Ameren and I will not wait for a Commission ruling on this matter.

Ameren Missouri has until the end of business on Monday October 23, 2023, to not only restore utility services without payment, but they also have until the end of business on Monday October 23, 2023 to admit that they tried to breach my network security and email accounts, along with the fact they failed to oblige by the payment agreement.

If Ameren doesn't restore services, take responsibility for their actions and admit to the PSC and other parties that they tried to Hijack my email and failed to oblige by the payment agreement, I will allow my data management and solutions provider proceed with filing a complaint with the Cyber Crimes Unit in their jurisdiction for email Hijacking and attempting a DDOS attack on my network Also known as email bombing .

In addition, I will be bringing this to the attention of the AG's Public Corruption Unit, to seek that Ameren Missouri and any and all parties that were involved in this matter from Ameren Missouri are prosecuted to the highest extent of the law.
