On September 29, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve the acquisition of the unregulated Country Life Acres sewer system and grant Confluence Rivers a Certificate of Convenience and Necessity (CCN) regarding the sewer system, which is located in Jefferson County, Missouri.

The Commission has issued notice of these applications, and the Commission has received no requests to intervene. Thus, the Commission will order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a Recommendation, or a status report stating when it expects to file its Recommendation, no later than November 29, 2023.
2. This order shall be effective when issued.
