At this point, Ameren Missouri has bigger issues that they should start paying attention to. such as the transcript that still to date hasn't been uploaded to EFIS. Mrs. Krcmar admitted to altering documents. Here own words. While she labeled them as her own "personal" documents and that is was "easy", Mrs. Krcmar nor did Ameren Missouri present anything that shows they were her "personal " documents.

The transcript of the evidentiary hearing was supposed to be uploaded into EFIS by last Wednesday October 18,m 2023, that to date mysteriously still hasn't been uploaded through EFIS. The same one that has Mrs. Krcmar stating that she "altered" documents and that it was "easy." Her exact words.

Next, I notice that Ameren Missouri doesn't want to talk about the possibly email HiJacking that I have introudced and that their IP address has been traced to. Why is that? Is that because Ameren Missouri knows they are lying and that they tried to DDOS attack not only my network, but also my email account using the tracking cookie at the bottom of the payment agreement?

As for the monies that Ameren claims they are in clear violation of Missouri State Statutute 570.095, in which is is agains the law and it is fraud and a person is committing fraud when trying to fraudulently charge and bill someone for items under dispute and have failed to validate the dispute and in attempted to negatively adverse someones credit rating as a result of it.

I would recommend that Ameren Missouri and counsel, Banks and Grubbs go back to an email that was sent disputing the debt balance, dates, etc. In which Ameren Missouri failed to supply a copy of all the documents to me within that 30 day window, as even the original creditor (which would be Ameren has to do that still). Ameren Missouri has also failed to and purposely ignore a complaint that was filed with the NCTUE, which is known as the National Consumer Telecom & Utilities Exchange. As a result I had to place a freeze on my utility reporting to protect and perserve my excellent rating that I have with utility companies and telecom agencies, which could adversely affect the outcome.

A police report has been registered, along with an FTC full dispute, which has been uploaded into the Consumer Sentinel Network. In the event Ameren Missouri, Aubrey Krcmar, Terri Englebrecht, Jermaine Grubbs try to place the matter with a credit collector, it will register a hit with law enforcement and parties involved will be subject to full prosecution under all applicable Federal and State Laws.

Ameren Missouri can state all they want, however, they still have to validate that a debt is valid when someone requests or disputes the debt. See, I wanted the transcript, therefore I could continue to prove that Ameren Missouri is a lair and a con artist company. That would solidify as it is on paper that Mrs. Krcmar stated she altered documents and it was easy.

I can also remember during the recording that the court report said she'd be willing to put a rush on the transcript, but was told that wasn't necessary and it should've been published or uploaded for parties by October 18, 2023. It's now October 23 and still no transcript. Also there was no response when I asked about it. Thanks for that.
