On December 14, 2018, a *Stipulation and Agreement* was filed by the Staff of the Missouri Public Service Commission and Union Electric Company d/b/a Ameren Missouri. Included as Attachment A to the *Stipulation and Agreement* were sample tariff sheets concerning interim rates conforming to the agreement.

On December 18, 2018, Ameren Missouri filed revised tariff sheets, in accord with the *Stipulation and Agreement* and sample tariff sheets. Those tariff sheets show an effective date of January 17, 2019. The Commission will set a time for any responses to Ameren Missouri's revised tariff sheets.

THE COMMISSION ORDERS THAT:

1. Any responses to Ameren Missouri's interim rate reduction tariff, YG-2019-0119, shall be filed no later than 12:00 p.m. on December 21, 2018.
2. This order is effective when issued.


