**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND
ESTABLISHING TIME FOR OTHER RESPONSES**

On November 20, 2018, the Commission suspended Union Electric Company d/b/a Ameren Missouri's Rider Missouri Forward and Rider EDRR economic development tariff (Tariff Tracking No. JE-2019-0051). After discussions among the parties, Ameren Missouri withdrew that tariff on December 19. In its place, Ameren Missouri filed a new economic development tariff (Tariff Tracking No. JE-2019-120). That revised tariff carries an effective date of January 18, 2019. Along with its revised tariff, Ameren Missouri filed a document explaining and supporting that tariff, as well as a proposed schedule for the filing of responses to its tariff.

The Commission will direct its Staff to file a recommendation and will establish times for other parties to file responses if they wish to do so.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Ameren Missouri's Rider EDI Economic Development Incentive and Rider EDRR Economic Development and Retention Rider tariff (Tariff Tracking No. JE-2019-0120) no later than December 28, 2018.

2. Any other party wishing to offer a recommendation regarding Ameren Missouri's Rider EDI Economic Development Incentive and Rider EDRR Economic Development and Retention Rider tariff (Tariff Tracking No. JE-2019-0120) shall do so no later than December 28, 2018.

3. Any party wishing to respond to any recommendation regarding Ameren Missouri's Rider EDI Economic Development Incentive and Rider EDRR Economic Development and Retention Rider tariff (Tariff Tracking No. JE-2019-0120) shall do so no later than January 4, 2019.

4. This order shall be effective when issued.
