ORDER DIRECTING RESPONSE TO STAFF RECOMMENDATION

On December 17, 2018, the Staff of the Commission filed a recommendation and memorandum regarding its review of Spire Missouri, Inc. d/b/a Spire Missouri West's, formerly known as Missouri Gas Energy, 2016-2017 Actual Cost Adjustment ("ACA"). Staff proposes financial adjustments to Spire Missouri West's ACA balance, and offers additional recommendations regarding several aspects of the company's operations. Staff asks the Commission to direct Spire Missouri West to respond to its concerns, comments, and recommendations within 45 days. The Commission will order Spire Missouri West to respond to Staff's concerns, comments, and recommendations discussed in Staff's memorandum.

THE COMMISSION ORDERS THAT:

1. Spire Missouri, Inc. d/b/a Spire Missouri West shall respond to the concerns, comments, and recommendations discussed in Staff's memorandum no later than February 4, 2019.

2. This order shall be effective when issued.
