On December 18, 2018, MidAtlantic Broadband, Inc., (“the Company”) pursuant to §67.2679.7, RSMo 2016, filed a *Notice of Change Application* for video service authorization in the following political subdivisions:

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in § 67.2679.7, RSMo 2016.

THE COMMISSION ORDERS THAT:

1. MidAtlantic Broadband, Inc. is granted authority to provide video service in the franchise area of each political subdivision set forth in the application and restated above; and

2. MidAtlantic Broadband, Inc. is granted authority to construct a video service network along, across, or on public rights-of-way for the delivery of video service to the extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.

3. This order shall become effective when issued, after which this case may be closed.
