

**ORDER DIRECTING FILING**

On March 9, 2001, the Office of the Public Counsel filed a Motion to Dismiss or Suspend a tariff filed by UtiliCorp United Inc. Commission Rule 4 CSR 240-2.065(3) requires that "[a]ny pleading to suspend a tariff shall attach a copy of the tariff." Public Counsel's Motion did not comply with the Commission's rule in that it did not include a copy of the tariff.

Public Counsel will be required to cure this defect.

**IT IS THEREFORE ORDERED:**

1. That the Office of the Public Counsel shall file, no later than March 15, 2001, a copy of the tariff that it asks the Commission to suspend.

2. That this order shall become effective on March 15, 2001.
