(the "Company") filed its application for a certificate of convenience and necessity ("CCN") and for a waiver. The Company has applied for a CCN authorizing it to construct, install, own, operate, control, manage, and maintain a sewer system for the public, located in unincorporated areas in Andrew and Nodaway Counties, Missouri. The Company has requested a waiver of the 60-day notice requirements of 4 CSR 240-4.017. On November 30, 2018, the Commission issued notice and a deadline of December 17, 2018, for intervention requests. None were filed. The Commission will Order the Staff of the Missouri Public Service Commission to file a recommendation.

1. The Staff of the Missouri Public Service Commission shall file a recommendation no later than January 26, 2019.
