## ORDER CANCELING CERTIFICATES AND TARIFFS

On September 20, 2018, the Commission issued an order approving a joint application seeking authority for Missouri-American Water Company to purchase the water and sewer assets of Rogue Creek Utilities Inc. On December 17, 2018, Missouri-American Water Company notified the Commission that the closing had been completed. Because of the transfer of assets, Rogue Creek Utilities Inc. is no longer providing water or sewer service in its certificated service territory. In accordance with its order approving the transfer and the agreement of the parties, the Commission will cancel Rogue Creek Utilities Inc.'s certificates of convenience and necessity to provide water and sewer service and the associated tariffs.

### THE COMMISSION ORDERS THAT:

1. Rogue Creek Utilities Inc.'s Certificate of Convenience and Necessity to provide water service is canceled.
2. Rogue Creek Utilities Inc.'s Certificate of Convenience and Necessity to provide sewer service is canceled.

3. Rogue Creek Utilities Inc.'s water service tariff, P.S.C. MO No. 3, Original Sheets No. 1-36, Tariff Tracking No. YW-2014-0222, is canceled.
4. Rogue Creek Utilities Inc.'s sewer service tariff, P.S.C. MO No. 4, Original Sheets No. 1-31, Tariff Tracking No. YS-2014-0221, is canceled.
5. This order shall be effective when issued.
6. This file shall close on December 27, 2018.
