On September 29, 2023,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve the acquisition of the regulated North Oak Sewer District, Inc. (North Oak), which is providing sewer service in the North Oak Estates subdivision in Warren County, Missouri.

The Commission has issued notice of these applications, and the Commission has received no requests to intervene. Thus, the Commission will order its Staff to file a Recommendation.
