Assuming arguendo, that the Commission has jurisdiction, a complaint must be based upon a violation of a "tariff, statute, rule, order or decision." 20 CSR 4240-2.070. It is MAWC's position that the additional two issues raised by Staff do not fall under any of these and are not appropriate for this forum.

3. Is Rule 3 of the Company's Rules and Regulations governing the Rendering of Water Service ("Rules and Regulations") Sheet No. R 11 relevant to whether MAWC's service related to the main break was safe and adequate?
