On November 30, 2018, Kansas City Power & Light Company filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism Rider. On December 3, 2018, the Commission issued an order directing notice, and setting a deadline of December 17, 2018, for intervention requests in this matter.

The Missouri Department of Economic Development – Division of Energy filed a timely application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.<sup>1</sup> The application satisfies all requirements of Commission Rule 4 CSR 240-2.075 and intervention will be granted.

### THE COMMISSION ORDERS THAT:

1. The application to intervene filed by the Missouri Department of Economic Development – Division of Energy is granted.
