ORDER GRANTING APPLICATION TO INTERVENE

On November 20, 2018, the Commission suspended Union Electric Company d/b/a Ameren Missouri's Rider Missouri Forward and Rider EDRR economic development tariff. The Missouri Department of Economic Development – Division of Energy applied to intervene on December 13.

More than ten days have passed since Division of Energy applied to intervene and no one has responded to that application. After considering the unopposed application to intervene, the Commission finds that allowing Division of Energy to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. Missouri Department of Economic Development – Division of Energy's application to intervene is granted.
2. This order shall be effective when issued.
