## ORDER CORRECTING THE REFERENCE TO THE TRACKING NUMBER OF THE TARIFF APPROVED IN A PREVIOUS ORDER

On October 31, 2018, the Commission issued an order that approved a disposition agreement regarding Middlefork Water Company's request for an increase in its annual water rate revenues. Middlefork filed a tariff to implement the agreed-upon rate increase and that tariff carried a January 1, 2019 effective date. The Commission's October 31, order approved that tariff to become effective on January 1, but incorrectly described it as tariff tracking number YW-2019-0067 rather than YW-2019-0066.

The Commission's records indicate Middlefork initially filed its compliance tariff at 9:40 a.m. on October 18. That compliance tariff was assigned tariff tracking number YW-2019-0066. At 9:51 a.m. on October 18, Middlefork filed a substitute tariff, which was erroneously assigned a new tariff tracking number, YW-2019-0067. Substitute tariffs are properly filed under the existing tariff tracking number rather than being assigned a new number. Consequently, the Commission's Data Center moved the substitute tariff filing into the existing YW-2019-0066 tariff tracking number.

The Commission's October 31 order correctly approved the substituted tariff, which had been filed at 9:51 a.m. on October 18, but incorrectly referred to it as tariff tracking number YW-2019-0067. Accordingly, the Commission will correct its October

31 order to refer to tariff tracking number YW-2018-0066. This correction will not affect the substance of the tariff that will go into effect on January 1, 2019 as previously ordered.

**THE COMMISSION ORDERS THAT:**

1. The Commission's October 31, 2018 Order Approving Disposition Agreement and Small Company Rate Increase is corrected to refer to and approve tariff tracking number YW-2018-0066.
2. This order shall be effective when issued.
