ORDER CANCELLING CERTIFICATE OF INTEREXCHANGE SERVICE AUTHORITY AND APPLICABLE TARIFF

On December 7, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificate of interexchange service authority and applicable tariff of Worldwide Telecommunications, Inc., (the “Company”) be cancelled at the Company’s request. On October 7, 2008, the Commission had granted the Company a certificate to provide interexchange telecommunication service in Case Number XA-2009-0055. The Company has a currently effective tariff, Tariff No. YX-2009-0148.

On December 7, 2018, the Commission issued its order giving any person wishing to respond to Staff's motion or wanting a hearing until no later than December 17, 2018, to file a pleading. The Commission need not hold a hearing if none is requested after due notice and opportunity to intervene¹ and may cancel the certificate and applicable tariff based on Staff's motion. No one has filed a pleading. The Commission will grant Staff's motion.

1. The certificate of interexchange service authority and the applicable tariff, Tariff No. YX-2009-0148, of Worldwide Telecommunications, Inc., are cancelled.
2. This order shall be effective when issued.
3. This file shall be closed.

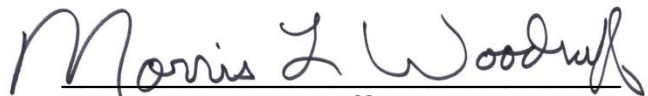
