On December 17, 2018, the Staff of the Commission filed its *Staff Recommendation Regarding Liberty Utilities' 2016-2017 Actual Cost Adjustment Filing*.

Staff recommends adjustments to Liberty Utilities' Actual Cost Adjustment account balances. Staff has further recommendations contained in its Official Case File Memorandum regarding billed revenue and actual gas costs, reliability analysis and gas supply planning, and hedging practices. Staff asks Liberty Utilities to respond within 45 days.

The Commission will order Liberty Utilities to respond.

THE COMMISSION ORDERS THAT:

1. Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities shall respond to Staff's recommendation no later than February 1, 2019.


