### **ORDER AND NOTICE OF APPLICATION**

On March 23, 2001, Missouri Gas Energy (MGE), a division of Southern Union Company, filed an application with the Missouri Public Service Commission (Commission) pursuant to Section 393.170, RSMo 2000, and 4 CSR 240-2.060(1) and (4) for a certificate of public convenience and necessity authorizing it to construct, install, own, operate, control, manage, and maintain a natural gas distribution system to provide gas service in Section 10 of Township 25 North, Range 32 West in Newton County, Missouri, as an expansion of its existing certificated area.

The Commission finds it appropriate that notice of this application be made to the general public and interested parties, and that a date for intervention of proper parties be set.

The Records Department of the Commission shall provide notice of this application to the County Commission of Newton County. Notice of this application shall also be given by the Information Officer of

the Commission to the members of the General Assembly representing Newton County, and to all publications of general circulation in Newton County as set out in the Official Manual of the State of Missouri.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and that the applicant may submit its evidence in support of the application by verified statement. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d, 494, 496 (Mo. App. 1989).

#### IT IS THEREFORE ORDERED:

- 1. That the Records Department of the Missouri Public Service Commission is directed to serve notice of this application to the County Commission of Newton County, Missouri.
- 2. That the Information Officer of the Missouri Public Service Commission is directed to serve notice of this application to the members of the General Assembly representing Newton County, and to all publications of general circulation in Newton County as set out in the Official Manual of the State of Missouri.
- 3. That any proper party wishing to intervene in this matter shall file an application to do so no later than April 24, 2001. Such application shall be filed with:
