WITH COMMISSION ORDER


On October 16, 2001, the Commission issued an Order Granting Certificate of Convenience and Necessity, allowing Missouri Gas Energy (MGE) to construct, install, own, operate, control, manage and maintain a natural gas service distribution system to provide gas service in Section D of Township 25 North, Range 32 West in Newton County, Missouri, as an expansion of its existing certificated area. On November 13, 2001, MGE filed a revised tariff sheet (tariff file no. 200200367) in compliance with the Commission's October 16, 2001, order. The tariff bore an effective date of December 12, 2001. The Staff of the Commission filed a Recommendation and Memorandum indicating that the proposed tariff complies with the Commission's order and should be approved.

The Commission has reviewed the tariff sheet, and the official case file, and finds that the tariff sheet complies with the Commission's October 16, 2001, order, and should be approved.

IT IS THEREFORE ORDERED:

1. That the tariff (tariff file no. 200200367) filed by Missouri Gas Energy on November 13, 2001, is approved to become effective on December 12, 2001.
2. That this order shall become effective on December 12, 2001.
3. That this case may be closed on December 13, 2001.


