**ORDER APPROVING COMPLIANCE TARIFF AND
GRANTING MOTION TO DISMISS**

Issue Date: January 2, 2019

Effective Date: January 16, 2019

On October 2, 2015, the Missouri Propane Gas Association (“MPGA”) filed a complaint with the Missouri Public Service Commission (“Commission”) against Summit Natural Gas of Missouri, Inc (“Summit”). The complaint concerned Summit’s conversion of certain appliances from propane gas usage to natural gas usage. On November 9, 2018, MPGA and Summit filed a stipulation and agreement, which states that Summit will only convert propane appliances to natural gas appliances if the appliance manufacturer makes available a conversion kit.

On December 17, 2018, Summit filed revised tariff sheets, tracking number YG-2019-0118, which reflects the stipulation and agreement. On December 19, 2018, MPGA filed a motion to dismiss its complaint against Summit. No responses to MPGA’s motion were received.

Commission Rule 4 CSR 240-2.116(1) states “Once evidence has been offered or prepared testimony filed, an applicant or complainant may dismiss an action only by leave of the commission, or by written consent of all the parties.” As testimony was

received on February 1, 2017, the Commission's leave to dismiss is required. The Commission will grant the motion and close the file.

THE COMMISSION ORDERS THAT:

1. The tariff sheets submitted by Summit, assigned Tracking No. YG-2019-0118, are approved to become effective on January 16, 2019. The specific tariff sheets are as follows:
