#### ORDER TO SHOW CAUSE

Issue Date: January 3, 2019 Effective Date: January 3, 2019

On December 4, 2018, the Missouri Public Service Commission ("Commission") issued its Order Setting Pre-Hearing Conference ("Order") for January 3, 2019, at 1:00 p.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 305. The Parties were ordered to appear. They were given the option to appear either in person or by telephone and given an access phone number and PIN to use if they wished to appear by phone. On January 3, 2019, the Commission called the case for hearing all as per its Order. All parties appeared except for William C. Fox, Sr., Complainant ("Mr. Fox"). Mr. Fox had not previously secured a continuance of the Pre-Hearing Conference.

4 CSR 240-2.090(5) provides:

"Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint, application or other action unless good cause for failure to appear is shown."

The Commission will order Mr. Fox to show good cause why his Complaint should not be dismissed for failure to appear at the prehearing conference on January 3, 2019.

#### THE COMMISSION ORDERS THAT:

- 1. No later than January 10, 2019, Complainant, William C. Fox, Sr., ("Mr. Fox") shall show good cause why his Complaint should not be dismissed for failure to appear at a pre-hearing conference on January 3, 2019 ("good cause").
- 2. If Mr. Fox fails to show good cause, then the Missouri Public Service Commission may dismiss the Complaint at any time after January 10, 2019, without further notice.
  - 3. This order shall be effective when issued.
