

“Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party’s complaint, application or other action unless good cause for failure to appear is shown.”

The Commission will order Mr. Fox to show good cause why his Complaint should not be dismissed for failure to appear at the prehearing conference on January 3, 2019.

THE COMMISSION ORDERS THAT:

1. No later than January 10, 2019, Complainant, William C. Fox, Sr., ("Mr. Fox") shall show good cause why his Complaint should not be dismissed for failure to appear at a pre-hearing conference on January 3, 2019 ("good cause").
2. If Mr. Fox fails to show good cause, then the Missouri Public Service Commission may dismiss the Complaint at any time after January 10, 2019, without further notice.
3. This order shall be effective when issued.


