ORDER DENYING MEDIATION REQUEST AND EXTENDING TIME PERIODS

On September 28, 2023, Dranel J. Clark and Aquilla Canada ("the Complainants") filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. On October 24, 2023, Ameren Missouri filed a *Request for Mediation*.

On October 25, 2023, the Complainants sent an email to all other parties in this matter that included the statement, "We do not feel that mediation at this point would either resolve or remedy the situation, as it stands."

Mediation is a voluntary process with which both parties must agree. The Complainants' statement indicates that they do not agree to participate in mediation of this complaint. Therefore, the Commission will deny Ameren Missouri's request for mediation.

Taking into account Ameren Missouri's request for mediation, the Commission will extend, by a day, the time by which Ameren Missouri is to file an answer or notice of satisfaction, and the time by which the Staff of the Commission is to file its investigative report.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri's request for mediation is denied.

2. Ameren Missouri shall file an answer to this complaint no later than October 31, 2023, and serve a copy upon the Complainants. All pleadings (the answer or notice of satisfaction of complaint) shall be mailed to:

3. The Staff of the Commission shall investigate this complaint and file a report
