**ORDER DIRECTING FILING OF REDACTED APPLICATION
AND REQUEST FOR WAIVER**

On November 29, 2018, United Services, Inc. (the “Company”) filed its *Application and Request for Waiver*. (“Application”) ¹ Because the Application contained confidential customer-specific information ² interspersed throughout the Application, the Commission changed the entire Application’s security designation from “public” to “confidential”. An Application, however, is a pleading which is a public record. ³ Because none of the Application is now available as a public record, the Commission will order the Company to file a redacted Application which removes all customer-specific information.

THE COMMISSION ORDERS THAT:

1. No later than January 15, 2019, United Services, Inc., shall file a redacted version of its *Application and Request for Waiver* which redacts all customer-specific information.
