On December 20, 2018, Wisper ISP, Inc. filed a notice indicating it has purchased control of Aurora Communications, Inc., which is currently certificated to provide basic local communications services in Missouri. Wisper ISP's notice was assigned File No. CM-2019-0193.

In the Commission's system for naming cases, the M in the CM designation implies that the Commission would be considering the approval of the merger of the two companies. In fact, the Commission will only consider the propriety of the change of name under which the company will operate. A name change is properly designated with an N. Therefore, File No. CM-2019-0193 has been closed and its contents moved to a new file, CN-2019-0205.


