# ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 10, 2019

Effective Date: January 20, 2019

On December 12, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting Telecom North America, Inc.'s certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunications service in the State of Missouri be cancelled. In File Number XA-2003-0191, the Commission granted the company a certificate of service authority to provide intrastate interexchange telecommunications service in the State of Missouri be service in the State of Missouri under the name 3U Telecom, Inc. In File Number TN-2010-0370 the company's name change and tariff, YX-2010-0738, were also approved.

Staff states in its motion that on December 7, 2018, Telecom North America, Inc. notified the Commission that it no longer wished to retain its certification to provide interexchange telecommunications services in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On December 13, 2018, the Commission issued an Order Establishing Time to Respond allowing parties until December 26, 2018, to file an objection or request a hearing. No objections or requests for a hearing were filed. The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Telecom North America, Inc., shall be canceled.

## THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Telecom North America, Inc. in File Number XA-2003-0191, is canceled.

- 2. Telecom North America, Inc.'s tariff, YX-2010-0738, is canceled.
- 3. This order shall become effective on January 20, 2019.
- 4. This case may be closed on January 21, 2019.
