On January 15, 2019, KCP&L Greater Missouri Operations Company filed a tariff sheet providing its current Quarterly Cost Adjustment pursuant to the approved stipulation and agreement in File No. HR-2009-0092. This filing additionally includes the Coal Performance Adjustment due to the Lake Road Generating Station, Boiler 5 planned outage from September through November 2018. The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation.


