Wisper ISP, Inc. has notified the Commission that it has acquired control of Aurora Communications, Inc. and intends to provide basic local telecommunications services and connected voice over internet protocol (IVoIP) services in Missouri under the name Wisper ISP, Inc. The Staff of the Commission responded on January 16, 2019, indicating the company has complied with all statutory and regulatory requirements for changing the name under which it operates. Staff recommends the Commission recognize the name change. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Aurora Communications, Inc. to Wisper ISP, Inc. in association with its provision of basic local telecommunications services and connected voice over internet protocol (IVoIP) services in Missouri.
