## ORDER DIRECTING THE FILING OF POST-HEARING BRIEFS

Issue Date: January 22, 2019

An evidentiary hearing was held on Claude Scott's complaint against Union Electric Company d/b/a Ameren Missouri on January 18, 2019. The transcript of that hearing is due to be filed on or about February 1, 2019. The Commission will direct the parties to file post hearing briefs to assist the Commission in making a decision, and to grant Claude Scott an opportunity to present additional argument.

The briefs shall explain whether Mr. Scott was overcharged for electrical services provided, and whether Mr. Scott was appropriately billed under the budget billing program. The Commission's Staff is not required to submit a brief pursuant to its request at the evidentiary hearing.

### THE COMMISSION ORDERS THAT:

1. The parties shall file posthearing briefs no later than February 15, 2019.

2. This order is effective when issued.


