ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On January 18, 2019, Union Electric Company d/b/a Ameren Missouri submitted an application requesting authority to issue and sell up to \$450,000,000 aggregate principal amount of additional long-term indebtedness ("New Indebtedness"). Ameren Missouri also seeks expedited treatment of its financing application, requesting that a Commission order on the application go into effect no later than March 2, 2019.

The Commission will direct the Staff of the Commission to file an expedited recommendation regarding Ameren Missouri's application.

THE COMMISSION ORDERS THAT:

1. No later than February 8, 2019, the Staff of the Commission shall file a recommendation regarding Ameren Missouri's application to issue and sell up to \$450,000,000 aggregate principal amount of additional long-term indebtedness.

2. This order shall be effective when issued.


