NOTICE OF EXPIRATION OF VIDEO SERVICE AUTHORIZATION

Issue Date: October 27, 2023

On July 12, 2023,¹ Consolidated Communications of Missouri Company d/b/a Consolidated Communications filed a letter with the Commission that Consolidated Communications will cease to provide video services on August 15. Consolidated Communications was granted its video service authorization in File No. KA-2008-0411.² On October 25, the Staff of the Commission (Staff) filed a motion recommending the Commission recognize the expiration of Consolidated Communications' authorization to provide video services.

The expiration of video service authorization is addressed in Section 67.285, RSMo (2016), which states:

A video service authorization shall expire upon notice to the public service commission by the holder of a video service authorization that it will cease to provide video service under such authorization.

Thus, under the statute, Consolidated Communications' video service authorization expired upon notice to the Commission that it will cease to provide video service under that authorization. The Commission acknowledges receipt of

notice by Consolidated Communications that it has ceased to provide video service. The expiration of video service authority does not affect Consolidated Communications' provision of broadband and voice services.

The video service authorization has expired by operation of law and no further action by the Commission is required. This file may be closed.
