ORDER GRANTING MOTION TO SUSPEND PROCEDURAL SCHEDULE

On January 28, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively, "the Companies"), filed a Motion to Suspend Procedural Schedule. In the motion, the Companies state that the parties are continuing negotiating and are considering extending the Companies' current MEEIA plan another year.

To that end, the Companies ask the Commission to suspend the procedural schedule until February 13, 2019, so that the parties may have more time to negotiate. The Companies state that no party other than NRDC opposes the motion. NRDC filed its objection on January 28, 2019, stating that it received little consultation or notice of such a momentous motion.

The Commission finds the motion reasonable, and will grant it expeditiously so that rebuttal testimony, which would otherwise be due today need not be filed.¹

THE COMMISSION ORDERS THAT:

- 1. The Motion to Suspend Procedural Schedule is granted.
- 2. The Companies shall file a stipulation or alternative pleading no later than February 13, 2019.
 - 3. This order shall be effective when issued.
