**ORDER EXTENDING DEADLINE
FOR STAFF RECOMMENDATION**

On December 28, 2018, the Missouri Public Service Commission (“Commission”) issued its *Order Directing Staff to File Recommendation* and therein ordered Staff to file its Recommendation no later than January 26, 2019. On January 25, 2019, Staff filed a *Status Report and Motion for Extension* (“Motion”) asking the Commission to extend the deadline for Staff’s Recommendation to no later than March 26, 2019. Staff’s Motion stated that it required more time “due to the number of separate systems included in the Company’s *Application*. . . .” The Commission will extend the deadline for Staff’s Recommendation.

THE COMMISSION ORDERS THAT:

1. The motion of the Staff of the Missouri Public Service Commission (“Staff”) to extend the deadline for filing its Recommendation is granted.
2. Staff shall file its Recommendation or an alternative pleading no later than March 26, 2019.
3. This order shall be effective when issued.
