On January 15, 2019, Spire Missouri, Inc. d/b/a Spire ("Spire") filed revised tariff sheets under Tariff Tracking Nos. JG-2019-0140 and JG-2019-0141 to increase annual funding to the Conservation and Energy Efficiency Program for Spire's Western Missouri operating division. The tariff sheets bear an effective date of February 14, 2019.

On January 29, 2019, the Commission's Staff filed a Motion to Suspend Tariff Sheets, recommending that the Commission suspend the tariff sheets to provide an opportunity for Staff to review the requested increase in program funding. The Commission will suspend the filed tariff sheets for 120 days to provide an opportunity to consider whether to approve the tariff sheets.

#### THE COMMISSION ORDERS THAT:

1. The tariff sheets submitted under Tariff Tracking Nos. JG-2019-0140 and JG-2019-0141 by Spire Missouri, Inc. d/b/a Spire, effective on February 14, 2019, are suspended until June 14, 2019.
