JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

COMES NOW, the Staff of the Missouri Public Service Commission, by and through counsel, and hereby files this Joint Motion To Amend Procedural Schedule on behalf of Staff, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company (collectively "the Companies") and the Office of the Public Counsel ("OPC") (collectively "the Parties").

1. The Parties have met on four occasions, most recently May 28, 2014, to discuss/address the Companies' Application for approval of its Cost Allocation Manual (CAM) filed on December 16, 2013. The Parties have agreed that more time is needed to discuss/address the specific provisions of the CAM prior to the filing of the next round of testimony. As a result, the Parties propose the following amended procedural schedule:

need for additional time to respond.

July 21-22, 2014 Settlement Conference in Jefferson City.

July 25, 2014 List of Issues, Order of Witnesses, Order of

Cross-Examination, etc.

July 31, 2014 Statement of Positions

August 6-7, 2014 Evidentiary Hearing

- 2. On a going forward basis, the Parties agree that they will provide to the other Parties all data and documentation relied upon in preparing each of their witnesses' pre-filed testimony on the same day of filing such pre-flied testimony.
- 3. The Parties do not believe that any other changes are necessary in the procedures that the Parties previously recommended to the Commission and that the Commission ordered in its Order Setting Procedural Schedule, issued February 6, 2014.

WHEREFORE, the Staff on behalf of the Parties in File No. EO-2014-0189, files the instant Joint Amended Procedural Schedule, and requests that the Commission adopt the proposed procedural schedule and procedures contained herein.
