## JOINT MOTION FOR ONE-DAY EXTENSION TO FILE SURREBUTTAL AND CROSS-SURREBUTTAL

COMES NOW the Staff of the Missouri Public Service Commission, by and through Staff Counsel's Office, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO"), and the Office of the Public Counsel ("Public Counsel") (collectively the "Parties") and request that the Commission extend the date for the filing of surrebuttal and cross-surrebuttal from Monday, July 14, 2014, to Tuesday, July 15, 2014. In support thereof, the Parties state as follows:

- 1. On June 5, 2014 the Commission issued an Order Granting Motion To Amend Procedural Schedule in which it granted the Parties' Joint Motion To Amend Procedural Schedule and set June 19, 2014 as the date for the filing of rebuttal by the Staff and the Office of the Public Counsel.
- 2. On June 20, 2014, the Staff filed a *Motion For Leave To Late-File Staff's Rebuttal Case*, one-day late. In said motion the Staff related that undersigned Staff counsel (1) had talked with Counsel for KCP&L and GMO, who had indicated that KCP&L and GMO had no objection to the Staff's motion for leave to late-file its rebuttal case, and (2) had advised Counsel for KCP&L and GMO and Counsel for Public Counsel that Staff had no objection to a modification of the current procedural

schedule to permit KCP&L, GMO, and Public Counsel an extension of time from July 14 to July 15, 2014, to file their surrebuttal and cross-surrebuttal cases.

3. The Parties now file their motion to extend the date for the filing of surrebuttal and cross-surrebuttal. The Parties do not believe that moving the date for the filing of surrebuttal and cross-surrebuttal from July 14, 2014 to July 15, 2014, will unduly delay the scheduled proceedings.

WHEREFORE the Parties pray that the Commission extend the date for the filing of surrebuttal and cross-surrebuttal from Monday, July 14, 2014, to Tuesday, July 15, 2014.
