1. The Commission will hold a status conference on November 9, 2023, at 2:00 p.m. and another status conference on November 20, 2023, at 2:00 p.m. The status conferences will be held via WebEx, and information to attend the status conferences will be sent to counsel for the parties prior to each status conference. Liberty and Staff must appear at the status conferences, but other parties are not required to attend.
2. Any outstanding issues must be submitted to the Commission two business days prior to any status conference.
3. This order is effective when issued.
