On April 24, 2023, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission pursuant to Section 393.1075, RSMo, and Commission Rules 20 CSR 4240-20.093 and 20.094 for authority regarding demand-side programs and a Demand Side Programs Investment Mechanism. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.

More than 180 days have passed since Evergy Missouri West, Inc. d/b/a Evergy Missouri West's filed its notice and by terms of the regulation, File No. EO-2023-0370 has closed.
