On December 31, 2018, KCP&L Greater Missouri Operations Company ("GMO") filed an application regarding its semi-annual Fuel Adjustment Clause true-up. On January 30, 2019, the Commission's Staff filed its recommendation. The Office of the Public Counsel ("OPC") filed a response to GMO's FAC rate adjustment. OPC requests that the Commission find GMO has over-collected \$55,005 and must return that amount to its customers.

Commission Rule 4 CSR 240-20.090(5)(D) requires that the Commission issue an order deciding the true-up within 60 days, or suspend the timeline of the true-up to receive additional evidence and hold a hearing if necessary.

The Commission will direct GMO and Staff to respond to OPC's concerns. Additionally, the parties shall also make a recommendation regarding how the Commission should proceed in this matter.

IT IS ORDERED THAT:

1. No later than February 14, 2019, GMO and Staff shall respond to *Public Counsel's Reply to the Staff's Recommendation*.

2. No later than February 14, 2019, the parties shall file a recommendation as

to how the Commission should proceed in this matter.

3. This order shall be effective when issued.
